 - e. District Supervisor of Social Studies / World Language / Director of Special Projects
- 2. Effective immediately following June 30, 2023, the following administrative positions hereby are created with the job descriptions developed and approved by the Superintendent:
 - a. Director of Academics: Humanities
 - b. Director of Academics: Science and Math
 - c. Director of Pupil Personnel Services

BE IT FURTHER RESOLVED that the Board of Education hereby authorizes and directs the Superintendent, utilizing the advice of Board Counsel as required, to take such personnel actions as are within her lawful powers and duties and to recommend such additional personnel actions as are necessary and required to implement the aforesaid reorganization, including but not limited to posting for candidates to fill the newly created positions, interviewing such candidates as the Superintendent, or her designee(s), determine to be qualified, and recommending the appointment of selected qualified candidates to the Board to fill the newly created positions, as well as providing legally required notices to all personnel adversely affected by the approved reorganization.
