Dear Lawmakers,

My name is John Migueis, and I administer Berkeley Heights Community Watch - a website dedicated to informing Berkeley Heights NJ Residents about their local Government.

If Bills S2930/A4505 had been in place over the past four years, the residents in our community would not have had access to the full school budget for our District or the costs associated with attorneys that have skyrocketed as a result of BOE ethics complaints.

Residents would not have known that our 2023 School Budget was approved without all BOE members having looked at it.

Through OPRA, emails between BOE Members have exposed how the former majority improperly used Attorneys to prevent newly elected BOE Members from voting on important issues.

OPRA allowed residents to understand how the administration attempted to influence elections improperly.

This is just the tip of the iceberg.

Based on the information obtained through OPRA, four new BOE Members were elected in three years. Our Superintendent has resigned effective May 2024.

The remnants of this majority are still actively working to hide and maneuver in incomprehensible ways to any thinking person today.

As it stands, our District **still** spends an excessive amount of time and money on Attorneys so that documents requested through OPRA are improperly redacted or denied, leading to suits that the District ends up settling at the last minute in an apparent attempt to delay information.

In one case, a BOE Member outright lied to a resident about the existence of a report connected to our proficiency declines during a BOE Meeting. Initially, the OPRA Custodian also denied it existed. Due to the force of the **current** law itself, we were able to obtain it.

Imagine what would happen in our community if these bills became law.

Imagine what would happen to communities around the state.

If passed, these bills would be a catastrophe for our community. The District already hides information most Districts make public, delays responses to requests, and uses attorneys to interfere with straightforward requests.

In fact, this very process and how these two bills are being rushed through are evidence that both OPRA and OPMA should be strengthened.

I attached a petition with 90 signatures (some signatures have been removed as they were out of state). The number may have increased since I sent this email. Most of these signatures are from residents of Berkeley Heights; however, other residents from around the state have also signed. You can view the online petition [here](#)
