WHEREAS, Cifelli & Son General Contracting is the lowest responsible bidder; and

WHEREAS, the Township Council finds that the best interests of the Township and the purpose of the New Jersey Local Public Contract Law would be served by accepting said bid;

NOW, THEREFORE BE IT RESOLVED by the Township Council that Cifelli & Son General Contracting Inc., be awarded a contract for Road Recon of Old Farm/Orchard/ Mercier project in the amount of \$451,838.45.
