Dear BHPS STAFF

I write in furtherance of my correspondence to you, dated September 17, 2024, in response to your request for records from the Berkeley Heights Board of Education ("Board" and/or "District"), pursuant to the Open Public Records Act ("OPRA") submitted and received via email on Friday, September 6, 2024.

OPRA allows custodians to seek extensions of time within which to respond, pursuant to <u>N.J.S.A.</u> 47:1A-5i. Specifically, OPRA states that, "the requestor shall be advised when the record can be made available. If the record is not made available by that time, access shall be deemed denied." In regards to your request, this office requested such an extension until Friday, October 11, 2024. Accordingly, the Board's response to your request is set forth below.

More specifically, your OPRA request seeks access to the following:

"I hereby request any and all communications, including but not limited to email (including both the official @bhpsnj.org email account and personal email) and/or cellular communication ('texting'), from Gale Bradford, Dipti Khanna, Sai Bhargavi Akiri, Thomas Foregger, Jordan Hyman, Nathasha Joly, and/or Pamela Stanley sent either TO, CC, or BCC Robert Nixon, Anthony Giordano, Jacqueline Bartlett, Dennis Dagounis, Ann Clifton, Marybeth Kopacz, Steven Hopkins, Ashley Janosko, Kelly Curtiss, and/or Laurie Scott between May 22, 2024 @ 7:49 am until June 7, 2024 regarding and/or containing any mention of employee Daniel McGovern and/or any mention or discussion of the email I sent on May 22, 2024 with the subject line No Confidence in Forreger, Continued Disgust in BHCW BOE Members and/or any mention or discussion of the email I sent on May 22, 2024 with the subject line Lapse in Ethical Judgement and/or any requests/demands/questions/suggestions regarding potential disciplinary actions towards the author of the two emails listed above."

As a preliminary matter, please take note that personnel records are not government records and are therefore prohibited from disclosure under OPRA. The OPRA only permits the disclosure of limited specific personnel information, specifically, the disclosure of an individual's name, title, position, salary, payroll record, length of service, date of separation and the reason for such separation, and the amount and type of any pension received. The statute further provides that records which disclose conformity with specific experiential, educational or medical qualifications which are required for employment are

also disclosable. Otherwise, personnel records of any individuals shall only be accessible when required to be disclosed by another law, the disclosure is essential to the performance of official duties of a person authorized by the State/United States, or when authorized by an individual in interest. See N.J.S.A. 47:1A-10 and Libertarians for Transparent Government v. Cumberland County, 250 N.J. 46 (2022).

The aforementioned request seeks copies of personnel records. Pursuant to <u>N.J.S.A.</u> 47:1A-10, personnel records are accessible when "authorized by an individual in interest". The authorization for disclosure of personnel records is inherent in a request for disclosure of the records when such a request is submitted by an individual in interest, or otherwise meant to mean, the person who is the subject of the personnel file. <u>See Mapp v. Borough of Roselle (Union)</u>, GRC Complaint No. 2009-334 (November 2010) and <u>Hewitt v. Longport Police Department</u>, GRC Complaint No. 2004-1489 (March 2005).

Accordingly, as your request seeks copies of personnel records, for which you are the subject, enclosed please find correspondences between Gale Bradford, Dipti Khanna, Sai Bhargavi Akiri, Thomas Foregger, Jordan Hyman, Nathasha Joly, and/or Pamela Stanley and Robert Nixon, Anthony Giordano, Jacqueline Bartlett, Dennis Dagounis, Ann Clifton, Marybeth Kopacz, Steven Hopkins, Ashley Janosko, Kelly Curtiss, and/or Laurie Scott for the period of May 22, 2024 through June 7, 2024 which have been redacted to protect confidential personnel information pursuant to <u>N.J.S.A.</u> 47:1A-10 and <u>N.J.S.A.</u> 10:4-12(b)(8). Please note, there are no text messages responsive to your request.

As the documents identified above are being provided to you in electronic format only, there is no charge associated with your request. The foregoing information and the enclosed documents constitute the Board's full and complete response to your OPRA request and therefore, your OPRA request is closed.

So yes, I see and know what has happened over the last few years. It has not gone unnoticed.


It is surprising to see that you are still holding on to these views, when you now should see the view from the other side.






On Wed, May 22, 2024 BOE Members,




